

POLICY: Catholic Character

The daily life of the College will be permeated with the values of Jesus Christ and the teachings of the Catholic Church. Special links will be maintained with the Sisters of Our Lady of the Missions as the College Founders and their special charism reinforced in the College. This policy is intended to build our Faith Community, uphold the mana of our Kura, and commit to the safeguarding of our Catholic Character and Mission Charism.

1.0 Purpose and Scope

The Catholic Character of Sacred Heart Girls' College is at our core. The Board of Trustees (the Board) in consultation with the Principal shall ensure that the Catholic Character of the College, namely its commitment to provide an education in which the Gospel values of the Catholic Church are promoted, will be maintained at all times. All policies, processes and practices will be measured against this Catholic Character.

2.0 Procedure

- 2.1 The Principal, Director of Religious Studies (DRS) and Director of Catholic Character and Mission Charism, in conjunction with all staff and all students, are responsible for promoting the Catholic Character within the College and our Parish Communities.
- 2.2 Therefore the Principal shall:
 - Ensure that the school policies, procedures and structures reflect the values of Jesus Christ
 - Encourage staff to reflect the Gospel values and support the Catholic Character of the College in their work and their attitudes and relationships with students and colleagues
 - Assist staff in their understanding of the Catholic Character of the College by encouraging a minimum of Level 1 Certification in Catholic Special Character and ongoing professional development
 - Ensure that the College culture and physical environment reflects our Catholic Character
 - Provide a spiritual retreat annually for each student.
- 2.3 Operational procedures relevant to this policy include:
 - The Proprietor's appointees on the Board of Trustees responsibilities for reporting to the Proprietor
 - Catholic Character sub-committee
 - Reporting to the Board at regular meetings
 - Provision of Chaplaincy Service
 - Orientation Programme to assist newly appointed staff in their understanding of the College Catholic Character
 - Time of prayer to be included in all meetings and classes
 - Implementation of the National Curriculum of Religious Education "Understanding Faith" secondary school syllabus
 - Provision of opportunities for the Board, staff, parents/caregivers, and students to take part in Sacramental or Liturgical celebrations.
